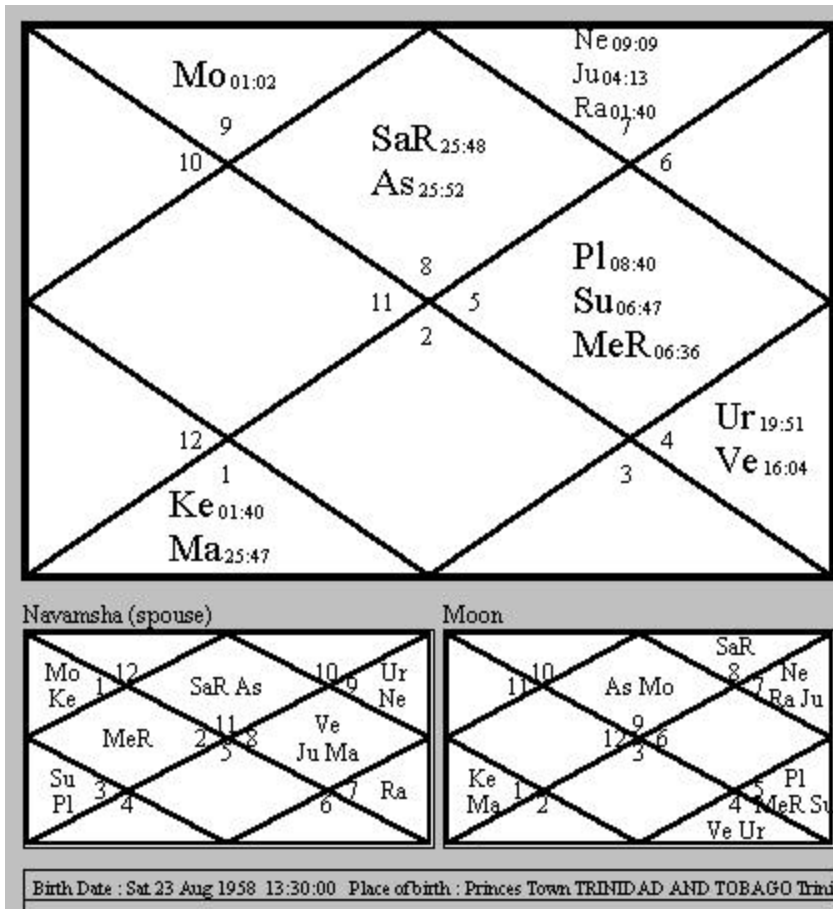

EXPLANATION OF BIRTH CHART:
