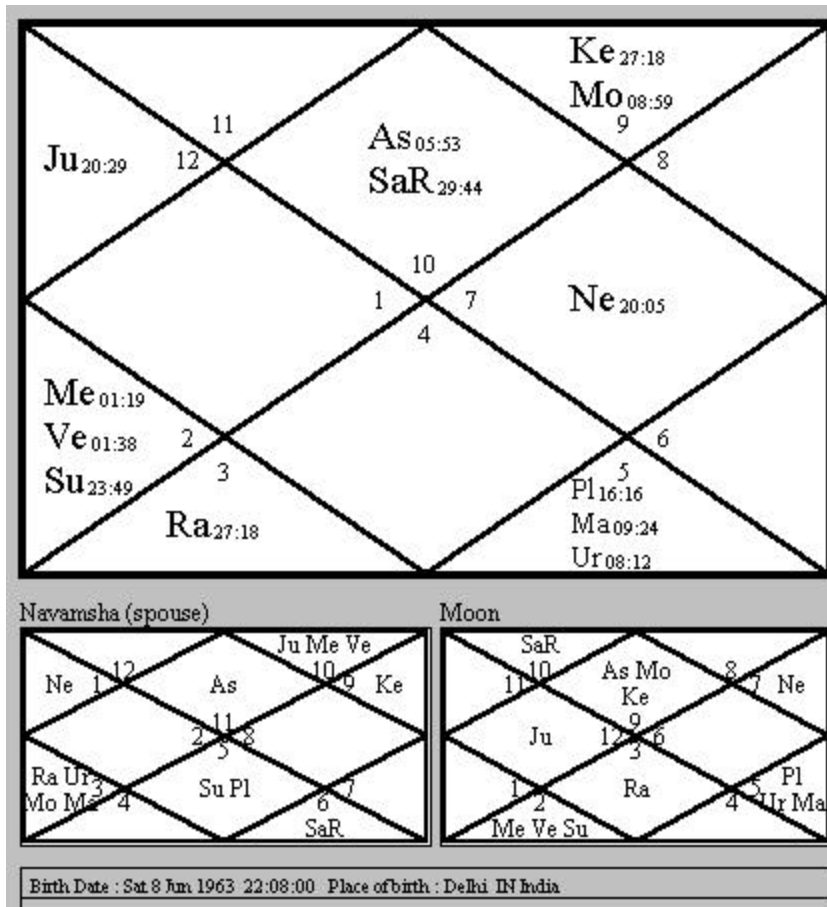

## Business Success Potential as per your natal chart:

Venus will rule your profession. Venus is related to life style luxury items. It also indicates Internet and advanced mobile applications.

Any high-end high technology as well as branded luxury items will be suitable for you.

You may not be very successful in distribution of low priced high volume consumer goods or services. Nor will you get any professional satisfaction or self-fulfillment in dealing with such goods and services.

### **10<sup>th</sup> house from Moon Sign:**

Moon is located in Sagittarius in your natal chart, which is 12<sup>th</sup> house from your Ascendant. The 10<sup>th</sup> house from moon sign in your chart is Virgo, which is ruled by Mercury. Mercury is the planet for business, distribution, transaction and communication. Mercury is located in 6<sup>th</sup> house from your Moon sign in Taurus.

Mercury authenticates your dealing with billing applications on mobile telephony.

However Mercury is weak in your natal chart and is not effective. This could be the reason for not achieving the desire level of success in your present venture.

### **10<sup>th</sup> house in 10<sup>th</sup> harmonic chart:**

The Ascendant of the 10<sup>th</sup> harmonic chart is Libra ruled by Venus. 10<sup>th</sup> house in the same chart is Cancer, which is ruled by Moon.

Moon signifies consumer goods in which you deal with general public. Moon is located in 12<sup>th</sup> house of your natal chart and is located in 5<sup>th</sup> house of your 10<sup>th</sup> harmonic chart. It is also lord of 7<sup>th</sup> house, the house of partnership. Moon signifies that you will be in partnership business.

### **Strategic Alliance and partnerships:**

The 7<sup>th</sup> house is the house of partnership. Lord of 7<sup>th</sup> house, Cancer in your natal chart is Moon. Moon is located in 12<sup>th</sup> house of your natal chart. 12<sup>th</sup> house indicates foreign connection.

This signifies, as per your chart, in your business, you should seek multinational and foreign partnership than Indian partnership. In mobile technology context, Hutch or foreign company will be more suitable for you than Reliance or Tata.

### **Wealth Potential in your chart:**

## Principles of Dasha System:

The Dasha Vichar or planetary periods of Vedic Astrology provide a unique and comprehensive system for judging the effects of planets throughout the development of our lives. They are the most accurate system for showing how the planets distribute their effects through time and the different stages of our lives.

The most common of these systems of planetary periods is the Vimshottari Dasha or the "120-year cycle". This follows a predetermined sequence, the starting point of which is determined by the longitude of Moon at the time of birth. In it, each of the seven major planets plus the two Lunar Nodes are given specific periods. This entire life span is divided into different main periods of planets and within this main period, there are sub-periods of all the planets and then each sub-period can be divided into sub-sub-periods of planets. The effects of the planets become most operative during the Main Dasha or the sub-Dasha. The transit effects and the relation between the Main planet and the sub-planet also determine whether the good effects will be more predominant or the bad one.

### **Astrological signatures for next 5 years for success in your profession:**

As already mentioned, since September 2001, you have been experiencing the main Dasha of Mars, which is located in 8<sup>th</sup> house. This has been a challenging period in your life. ### **Astrological Remedy:**

You should strengthen the planet Mercury by wearing an ***Emerald*** weighing 5 to 7 carats in potency. It must be mounted on a gold ring and worn on the little finger of your right hand. The gem must be put on first on a Wednesday morning, preferably when the Moon is waxing.

2) For overall protection in every aspect of your life including health you should also strengthen Lord of your Ascendant Saturn with Gem therapy, which is retrograde in your natal chart.

You should strengthen the planet Saturn by wearing a **Blue Sapphire** weighing 3 to 5 carats in potency. It must be mounted on a gold ring and worn on the middle finger of your right hand. The gem must be put on first on a Saturday morning, preferably when the Moon is waxing.

3) You can also strengthen the most beneficial planet Venus in your chart by Gem therapy also. However it is not mandatory as Venus is already quite strong. But Gem therapy will make it even stronger and more effective.

You should strengthen the planet Venus by wearing a **Diamond** weighing 0.6 to 1.0 carats in size. It must be mounted on a gold or white gold ring and worn on the middle finger of left hand. The gem must be put on first on a Friday morning, preferably when the Moon is waxing.
